Program Policies

Registration Policies

A completed application for each camper with full deposit is necessary to process camper registration.

Deposits

A \$500 per child is required with registration. This includes a \$100 non-refundable and non-transferable application fee.

Balance of Fees

The balance of the camp fee is due on or before May 15, 2012. After May 15, camp fees are to be paid in full at the time of registration.

Refunds

All cancellations must be done in writing and submitted to the Baker Demonstration School office. If cancellation occurs:

- prior to March 1, 2012, \$100 will be withheld
- between March 1 and May 15, 2012, \$300 will be withheld
- after June 1, 2012, all camp fees will be withheld

Discounts

Early Bird Discount: Register by March 1, 2012, to receive \$75 off the registration fee for each camper. To enjoy the discount, a camper must be enrolled for four weeks or more.

Health Forms

All health forms must be completed and turned in prior to the first day of camp.

Baker Demonstration School and the Summer Discovery Program reserve the right to cancel any program if unforeseen circumstances occur.

Baker Demonstration School and the Summer Discovery Program will make every attempt to accommodate all children. The Summer Discovery Program will not accept children who are a danger to themselves or others. Any child who is a disruption to normal activities making it unreasonably difficult for other children to enjoy the summer program will be grounds for dismissal from the program. A parent or guardian is encouraged to call Baker Summer Discovery to discuss any special circumstances or conditions involving his/ her child prior to registration.

Neither Baker Demonstration School nor the Baker Summer Discovery provides accident insurance for campers.

I consent to my child's participation in Baker Demonstration School's Summer Discovery program 2012. I acknowledge that participation in the Baker Summer Discovery program includes inherent risks. I expressly assume the risk of any and all injuries (including death), illness, or damage to property or loss that may result from my child's participation in the Summer Discovery program's activities.
